

1.5 BAR TO ACTION

The Participant agrees that this Deed may be pleaded as a bar to any action, suit or proceedings taken at any time by the Participant against Battlefield Live arising out of or as a consequence of Battlefield Live, the Battlefield Live venue or any incidental activities.

1.6 BINDING ON SUCCESSORS

This Deed binds the heirs, administrators, executors, personal representatives, dependants (if any) and successors of the Participant and enures for the benefit of Battlefield Live and its successors and assigns.

1.7 PRIVACY

Battlefield Live collects information from you for the primary purpose of providing quality outdoor Battlefield Live entertainment. We require you to provide us with details so that we may properly attend to your needs. This means we will use the info you provide in the following ways: administrative purposes, billing purposes (if required), disclosure for research and quality assurance activities to improve entertainment services, and if needed, emergency situations whereby staff/hospitals require access to a participants records for appropriate purposes. We will never sell, trade, loan or give your information to a third party unless we deem it necessary for safety or health reasons.

1.8 DAMAGE TO EQUIPMENT

If the Participant is witnessed causing Any Loss or it can be shown(even through circumstantial evidence) that the participant caused Any Loss, including equipment expressly or implicitly assigned or not assigned to the Participant or for the Participant's use or present at the Battlefield Live Venue at the discretion of Battlefield Live: Mike's Combat Games, LLC for the enjoyment of the Participant then Battlefield Live: Mike's Combat Games, LLC may claim the full cost of replacement or repair against the Participant. It will be at the sole discretion of Battlefield Live: Mike's Combat Games, LLC whether the equipment is repaired or replaced at cost to the Participant. This clause also includes Any Loss to a Battlefield Live Venue, including property or persons which are present at any Battlefield Live Venue but which are not present because of the activities that Battlefield Live: Mike's Combat Games, LLC is promoting.

1.9 DEFINITIONS

In this Deed unless inconsistent with the context or subject matter:

"All Claims" means all claims, actions, suits, demands, damages, interest and costs arising out of or as a consequence of Battlefield Live, including any incidental activity;

"Any Loss" means any loss, damage or injury to person (including the Participant) or property including but not limited to:

(a) Any damage or injury occasioned to a participant, howsoever, by:

- i) Any logs, trees and branches or any part thereof;
- ii) Any rocks, falling boulders or stones;
- iii) Any rivers, creeks, streams or any other body of water existing at a Battlefield Live Venue;
- iv) Any snakes, spiders or any other wildlife whatsoever;
- v) Other participants;
- vi) Any equipment supplied to the Participant by Battlefield Live in connection with Battlefield Live;
- vii) or otherwise arising out of the Participant's involvement in Battlefield Live.

(b) Any damage or injury occasioned to a Participant as a result of a Participant:

- ° Slipping on rocks, boulders, logs, trees, land or any other substance; and/or
- ° Falling over; and/or
- ° Colliding with another participant

whether caused by Negligence, Accident, Another Participant, Flora, Fauna or however otherwise caused.

"Battlefield Live" means the outdoor action roleplay combat game run by Battlefield Live: Mike's Combat Games, LLC trading as Battlefield Live, Mike's Combat Games, Lasertag and/or Laser Tag.

"Battlefield Live Venue" means the location at which Battlefield Live/Laser Tag is being convened;

"Participant" means their FULL NAME, and ADDRESS as per section one of this form.

"Battlefield Live" means a business of Battlefield Live: Mike's Combat Games, LLC - 1998 Woodlawn Ave; Eugene, OR 97401 and its agencies, suppliers, distributors, servants, employees, agents, representatives, directors, and officers.
